ORDINANCE 2524

AN ORDINANCE APPROVING AMENDMENTS TO THE HURST LAND USE ASSUMPTIONS, CAPITAL IMPROVEMENTS PLAN, AND MODIFICATIONS OF THE IMPACT FEES MAXIMUM ALLOWABLE LEVELS AND COLLECTION LEVELS AND REPLACING TABLES 1, 2, AND 3 IN ATTACHMENT "A" FOR TABLES 1, 2, 3, AND 4, ADOPTED BY REFERENCE AS PART OF ARTICLE II OF CHAPTER 21 OF THE HURST CODE OF ORDINANCES

- **WHEREAS**, the notices have been published, public hearings have been held, and the written recommendation of the advisory committee has been received by the City of Hurst City Council; and
- **WHEREAS**, the City of Hurst City Council finds that the amendments proposed have been formulated in accordance with and meet the requirements of Chapter 395, Texas Local Government Code and should be adopted; and
- **WHEREAS**, the City Council of the City of Fort Worth has adopted Ordinance No. 25101-09-2021 providing for new water and wastewater impact fee maximum assessable and collection levels pursuant to Chapter 395 of the Texas Local Government Code; and
- WHEREAS, the City of Hurst City Council finds that the amendments proposed allow the City of Hurst to collect the impact fees for the City of Fort Worth from Hurst's future water and wastewater customers, in accordance with and as required by, our current contracts with the City of Fort Worth for potable water and wastewater collection service.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HURST, TEXAS:

- Section 1. **THAT** the amended land use assumptions, capital improvements plan, and modification of the impact fees based on the "Water and Wastewater Impact Fee Update" study prepared by Freese and Nichols, Inc. dated July 21, 2022 on file in the office of the City Secretary is hereby approved and adopted as the updated impact fee plan for the City of Hurst.
- Section 2. **THAT** the revised impact fee levels shown in amended Tables 1, 2, and 3 in Attachment "A" represent the City of Hurst adopted water and wastewater impact fees and the water and wastewater impact fees adopted by the City of Fort Worth and are required to be passed through and paid by the City of Hurst customers.

Section 3. **THAT** Article II of Chapter 21 of the Hurst Code of Ordinances is hereby amended by replacing Attachment "A" hereto and Tables 1, 2, and 3 contained therein for Tables 1, 2, 3 and 4 referred to in such Article.

Section 4. **THAT** this ordinance will become effective on January 1, 2023.
