The meeting was called to order at 5:00 p.m. and the Pledge of Allegiance and Texas Pledge was given.

Mayor Pro Tem Shepard gave the Invocation.

1. Presentation and acceptance of the Annual Comprehensive Financial Report (ACFR) by FORVIS

City Manager Clay Caruthers reviewed the audit process prescribed by Charter to provide an independent and objective review. He stated the City is in sound financial position and noted the General Fund has a 4.5% increase in overall expenditures, which fits the inflationary environment at the time. He stated the net position increased about 10% due primarily to COVID proceeds. Also noted the Conference Center is back at the break-even point and the activity levels continue to rise. Mr. Caruthers reviewed General Government costs being public safety, public works and capital outlay and debt infrastructure, which are 74% of the general government spend, with cultural and recreation at 18% for a total of 92%. This leaves 8% overhead including administrative items such as legal, finance and human resources. Assistant City Manager Clayton Fulton introduced the FORVIS auditing firm Director Rachel Ormsby and Senior Manager Josh Findlay noting the audit handout including the single audit. He stated FORVIS provided Council an overview in their last City Council Work Session and the numbers have not changed since that time. Ms. Ormsby stated she is pleased to present the final audit this evening and as anticipated in the last presentation, it is a clean and unmodified opinion. She stated the audit has been filed as required with the proper agencies and contains the required disclosures and the single audit will be filed next week. Ms. Ormsby reminded the Council to keep cyber security in the

forefront and thanked City staff for their support and team work. Mayor Wilson also noted the quality of the City's finance department and thanked FORVIS for their work. Managing Director of Finance Paul Brown thanked FORVIS, City Manager Caruthers and Assistant City Manager Clayton Fulton for their support.

Councilmember Miller moved to accept the audit. Motion seconded by Councilmember McKenzie. Motion prevailed by the following vote:

- 1. Call to Order The meeting was called to order at 7:42 a.m.
- 2. Discussion and review of City of Hurst Strategic Planning Document including but not limited to discussions pertaining to key elements, accomplishments and priorities (Facilitator Joe Gonzalez, The Management Connection)

City Manager Clay Caruthers provided an overview of the agenda and his appreciation for Council, their hard work and support of staff. Mr. Caruthers also expressed appreciation for Councilmember Booe and his support of him over the years and thanked him for his service to the City. Mr. Caruthers provided a brief analysis of what he believes are Hurst's current Strengths, Opportunities, Weaknesses and Threats. He noted the Council's strength in leadership and professionalism, the positive organizational

culture and strong financial position of the City among a few. Also, expressed were challenges including the City being built out, relatively low tax base, employee turnover with the Great Resignation and retirements, financial and other challenges through inflation, rising wage pressures, health care costs and legislative challenges. Mr. Caruthers also noted opportunities that arise from some challenges including a refresh of ideas, collaboration through public/private partnerships and regionalism. He stated Executive Director of Human Resources Stephanie Jenkins, and Assistant City Manager's Clayton Fulton and Malaika Marion Farmer will provide additional information regarding some of these items.

Assistant City Manager Clayton Fulton reviewed results from this year's citizen survey noting, this year, staff partnered with a consultant to provide better visuals of the information. He noted that year-to-year, the results are fairly consistent, with public safety, and infrastructure being rated as highest priority. The survey also indicated citizens believe they can generally find what they are looking to buy in Hurst. He noted 89% of citizens feel satisfied or very satisfied with the quality of life in Hurst and 77% view Hurst taxation favorably. He provided details of each question and Council discussed survey responses and areas of focus. City Manager Caruthers stated staff will review any issues during their staff meeting and will take care of what they are able to address. He also noted the benefits of the data collected to help focus where there are needs. Staff noted debt capacity available for road improvements becoming available in the next few years and also discussed other opportunities for increased revenue to address aging infrastructure and recreational and facility needs. Assistant City Manager Fulton noted most survey respondents said they receive the majority of their news and information about the City through City email notifications, City website and Where We Live magazine. Staff also noted other communication efforts they may revisit due to cost benefit.

Mayor Wilson recessed the meeting at 9:00 a.m. and reconvened at 9:21 a.m.

Facilitator Joe Gonzalez led Council through a discussion regarding the Strategic Planning document including policy statements and strategies, which support the Strategic Plan foundation including the Vision and Mission Statement, and Community Values. He stressed the importance of strategic thinking necessary of a strategic leader and the consistent and professional manner in which Council conducts themselves in providing direction for staff to work on the day-to-day connection to long-term priorities. He noted the importance of patience during organizational transition and support for the new Councilmember joining the team to help him with the landscape and understand strategic thinking. Council discussed the benefits of thinking strategically as a body for the community. Mr. Gonzalez led a facilitated discussion on the Council's vision, mission and priorities. Council discussed combining the strategic priority of Redevelopment with the overall umbrella of Community and Economic Vitality due to the connection of one to the other and connecting staff actions to the respective priorities.

Mayor Wilson recessed the meeting at 10:44 a.m. and reconvened at 11:02 a.m.

Facilitator Joe Gonzalez reiterated the importance of strategic planning/thinking and then the management of the plan by staff with an end result of citizens being served in a very deliberate way. He thanked the Mayor and Council for allowing The Management Connection to be part of the process. Mayor Wilson emphasized the proven success of the strategic planning process and City Manager Caruthers also expressed the benefit of consistency of work as staff follows Council priorities.

3. Discussion of strategic planning initiatives relative to policy and legislative update, customer service initiatives, economic conditions, departmental and budget impacts

Staff provided various departmental updates and budget impacts. Executive Director of Human Resources Stephanie Jenkins provided a personnel overview including review of staff training, retention and leadership development. Assistant City Manager Malaika Marion Farmer reviewed leadership development and organizational culture utilizing the Code of Ideals as the foundation, Good to Great framework as the vehicle for organizational development and The Hurst Way as one of the principles that came from the Good to Great framework. Staff noted future focus will be on training new employees for the continuance of the Hurst culture. City Manager Caruthers reviewed several strategies being utilized to address personnel challenges including staffing, retention of knowledge, health and benefits.

Mayor Wilson recessed the meeting at 11:53 a.m. and reconvened at 12:11 p.m.

Staff continued department updates and Executive Director of Community Services Kyle Gordon provided an update on the upcoming aquatics season, staffing challenges and the goal to have both centers open at various times this season. Discussed were pros and cons to the rotation and the programing of each due to specific amenities. Mr. Gordon provided staff visioning in the area of Central Park to address recreation needs, aging infrastructure, and staffing restraints. Staff expressed their desire to provide a sense of place and a next in line facility to meet community needs. City Manager Caruthers stated these items will require discussions and planning during the budget work session. He stated depending upon Council's vision, items could be taken in phases or one large project, which would need voter approval for funding. Staff also discussed additional options noting the Hurst Sustainability Plan and need for additional residential property. City Manager Caruthers stated staff is only brain storming at this point and will wait for Council direction. Assistant City Manager Clayton Fulton provided a review of shortterm capital projects including water and wastewater, street and drainage, building, fleet, and facility and parks and recreation projects. Councilmember McKenzie briefed Council on his TML legislative update meeting noting the impact some bills will have on the City and the importance of communication with local and state representatives. He also advised of additional updates provided by TML through zoom sessions. Staff also noted recent completed policy updates, ordinance amendments and those that will be considered by Council in the future. City Manager Caruthers thanked staff for their work on these items. Mayor Wilson also thanked staff and Council for going through this vital exercise.

Background/Analysis:

Ms. Colleen Train, owner of Lot 18, Block 3, Lonesome Dove Estates (769 Trails End Circle) desires to construct a swimming pool in the rear yard. The yard area available is limited and she has requested the interior 5' of an existing 10' wide utility easement located along the rear property line be abandoned to provide additional space for the pool and associated patio.

Ms. Train has completed the "Application for the Vacation of the City of Hurst Utility and/or Drainage Easement" (Exhibit 1), and provided a boundary survey of the lot including a metes and bounds description with boundary survey of the lot depicting the subject 5' utility easement requested for abandonment (Exhibit 2), and signed agreement by franchise utility companies Oncor, Charter Cable, AT&T, and ATMOS, agreeing to abandonment of the easement (Exhibit 3).

As the City of Hurst does not currently have any utilities located within the subject portion of this easement, and does not envision a future need to locate utilities within this portion of the easement, we have no objection to abandonment of the easement and release of our rights to the use of this portion of the original easement.

Funding Sources and Community Sustainability:

There is no fiscal impact. This action is consistent with Council's strategic priority of **Customer Service** to the citizens of Hurst.

Recommendation:

It is recommended that the City Council approve Ordinance 2534, second reading, to vacate and abandon a 5-foot wide strip of a 10-foot wide Utility Easement platted as part of Lot 18, Block 3, of the Lonesome Dove Estates subdivision.

THAT the <u>most southerly five (5ft) foot portion of the existing ten (10') foot utility easement</u> located within the property as described in Exhibit "2", attached hereto, and incorporated herein for all purposes, is hereby abandoned and vacated for public use and the same is hereby vacated insofar as all public right, title, and interest in and to said <u>most southerly five (5ft) foot portion of the existing ten (10') foot utility easement</u> is concerned.

Section 3:

THAT the terms and provisions of this ordinance shall be deemed to be severable, and if validity of any section, subsection, word, sentence, or phrase shall be held invalid, it shall not affect the remaining part of this ordinance.





Background/Analysis:

Since 2009, the Hurst Senior Activities Center has hosted tens of thousands of visitors, programs, classes, and events. Currently, 1,200 members visit the center 6,000 times per month and enjoy ample opportunities to socialize and engage in any number of leisure pursuits.

However, before 2009, the facility served as a retail business originally constructed in the 1970s, and to limit construction costs, the City repurposed the original foundation. Unfortunately, during the fall of 2022, staff recognized that the east portion of the building began to show signs of movement. The areas impacted include the multi-purpose room, café, commercial kitchen, and fitness center. After partnering with specialized engineers, staff determined that approximately 3,200 sq.ft. of the fifty-year-old foundation requires repair.

To restore the slab to its original condition, the City partnered with Architectural Consulting Engineers, Inc., to develop a design solution. The engineering report recommends injecting approximately 2,300 lbs. of material into the void space below the slab to lift it back to the original condition. Staff and the engineers worked closely with Falkenberg Construction Company, Inc., to coordinate the repair program, provide pricing for the proposed foundation work, and repair cosmetic damage to cracked interior walls. As a result, staff received a quote in the amount of \$65,429 (including a 10% contingency) for the repairs. The City of Hurst is a Choice Partners purchasing consortium member, which provides substantial cost savings for construction services from Falkenberg Construction Company, Inc., and allows the City to utilize them directly.

Funding and Sources:

Funding in the amount of \$65,429 (including a 10% contingency) is available in the Special Projects Fund.

In an effort to remain a vibrant community, this project addresses the City Council's Strategic Priorities for **Infrastructure, Innovation**, and **Leadership** by providing an environment for all Senior Activities Center members to enjoy the pursuit of lifelong learning and engaging programming.

Recommendation:

It is recommended that the City Council authorize the city manager to proceed with the Hurst Senior Activities Center Foundation Repair Project for an amount not to exceed \$65,429.

Background/Analysis:

The City Council approved Ordinance 2260 on August 26, 2014 that established the areas along City streets where parking is prohibited. The proposed addition to that list of street areas is the first 135 feet west along the south side of Redbud Drive from the Brown Trail intersection. This will provide more room for buses and fire trucks to enter and exit this side of the intersection.

Funding Sources and Community Sustainability:

There is no financial impact.

Designation of No Parking areas is directly representative of the Council's goal of **Public Safety**.

Recommendation:

It is recommended that the City Council approve Ordinance 2535, first reading, amending Chapter 24 by adding a sentence to Section 24-127; prohibiting parking in a certain area on Redbud Drive near Brown Trail.

ORDINANCE 2535

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF HURST, TEXAS, AMENDING THE HURST CODE OF ORDINANCES CHAPTER 24 BY ADDING TO SECTION 24-127; PROHIBITING PARKING IN CERTAIN AREAS; PROVIDING A SEVERABILITY CLAUSE; PROVIDING A PENALTY; AND PROVIDING AN EFFECTIVE DATE

- WHEREAS, the City Council (the "City Council") of the City of Hurst, Texas (the "City"), has appointed a Transportation Infrastructure and Safety Committee to act in an advisory capacity to the City Council in all matters pertaining to traffic safety; and
- **WHEREAS**, the Transportation Infrastructure and Safety Committee has determined, after reasonable consideration, that parking should be prohibited on the streets provided herein; and
- **WHEREAS**, the City of Hurst is a Home Rule municipality having full powers of self-government and may enact ordinances relative to its citizens' health, safety, and welfare that are not inconsistent with the Constitution and laws of the State; and
- **WHEREAS**, Section 311.001 of the Texas Transportation Code provides that a home-rule municipality has exclusive control over and under the public highways, streets, and alleys of the municipality; and
- **WHEREAS,**Section 545.302 of the Texas Transportation Code prohibits stopping, standing, or parking in certain areas, including areas where an official sign prohibits stopping, standing, or parking; and
- **WHEREAS**, the City of Hurst has determined that it is a necessity to regulate activities as provided for herein to safeguard the public; and
- **WHEREAS,** the City of Hurst is authorized by law to adopt the provisions contained herein, and has complied with all the prerequisites necessary for the passage of this Ordinance; and
- WHEREAS, all statutory and constitutional requirements for the passage of this Ordinance have been adhered to, including but not limited to the Open Meetings Act; and
- **WHEREAS,** the purpose of this Ordinance is to promote the public health, safety, and general welfare of the citizens of the City of Hurst.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HURST, TEXAS:

- Section 1. **THAT** the statements contained in the preamble to this Ordinance are hereby adopted as findings of fact and as a part of the operative provisions hereof.
- Section 2. **THAT** the City of Hurst Code of Ordinances Chapter 24 is hereby amended by adding the following sentence to Section 24-127:
 - "Redbud Drive on the south side from Brown Trail to a point one hundred and thirty-five (135) feet west of Brown Trail."
- Section 3. **THAT** all ordinances or any parts thereof in conflict with the terms of this ordinance shall be and hereby are deemed repealed and of no force or effect.
- Section 4. **THAT** any person violating any of the provisions of this ordinance shall be deemed guilty of a misdemeanor and shall be fined an amount not to exceed \$500.
- Section 5. **THAT** if any section, subsection, sentence, clause or phrase of this ordinance shall for any reason be held to be invalid, such decision shall not affect the validity of the remaining portions of this ordinance.
- Section 6. **THAT** the fact that the present ordinances and regulations of the City of Hurst, Texas are inadequate to properly safeguard the health, safety, morals, peace and general welfare of the inhabitants of the City of Hurst, Texas, creates an emergency for the immediate preservation of the public business, property, health, safety and general welfare of the public, which requires that this ordinance shall become effective from and after the date of its passage, and it is accordingly so ordained.

Background/Analysis:

The City Council approved an Interlocal Agreement with the City of North Richland Hills (NRH) January 8, 2002 providing median access and maintenance to NRH for sign placement and irrigation. The agreement also provided responsibility to the City of Hurst for traffic signal operation and maintenance at Precinct Line Road and Mid-Cities Boulevard and Precinct Line Road and Martin Drive. The City of North Richland Hills has requested installation of a license plate reader in the median at Glenview Drive and Loop 820, necessitating the need for amendment to the original agreement. As such, staff believes it beneficial for the traffic signal operation and maintenance at the stated intersections to be relinquished to the City of North Richland Hills, who has the majority of the intersections in their city limits and who responds to accidents in these intersections.

Staff will present the amended Interlocal Agreement to the City of North Richland Hills for their consideration if Council approves the proposed amendments.

Funding Sources and Community Sustainability:

By relinquishing the traffic signal operation and maintenance, the annual cost savings to the City of Hurst is estimated to be \$3,000 in materials and labor.

Amendment of the Interlocal is directly representative of the Council's goal of **Public Safety and Infrastructure**.

Recommendation:

It is recommended that the City Council authorize the city manager to enter into an Amended Interlocal Agreement with the City of North Richland Hills regulating traffic signals operation and maintenance and Glenview Drive median maintenance.
