



# City of Hurst Parks Division Adopt-a-Park

#### How to Adopt-a-Park

- 1. An Adopt-a-Park Commitment Form must be completed for each group, and each potential participant must sign a Volunteer Registration and Release Form. Minors under the age of eighteen (18) must have a parent/guardian signature.
- 2. The forms are available from the Parks Division or may be downloaded from the Parks Division webpage.
- 3. The first workday needs to be scheduled with the Parks Division. A staff member will give a brief orientation to the group on the first workday.

#### Things to Know

- 1. A group/organization must list a contact person. This person is responsible for coordinating workdays with the Parks Division and reporting any issues to staff.
- 2. A group/organization must list three (3) tentative dates in the year for working in the park. The dates can be any day of the week.
- 3. A group/organization should list one or more parks it wishes to adopt. The parks available for adoption are listed on the Parks Division webpage or obtained by calling 817.788.7220.

#### City of Hurst Parks Division Adopt-a-Park Volunteer Guidelines

- 1. A group or organization interested in performing volunteer activities must contact the City's Parks Division and be given permission by the Director, or their designee.
- 2. The volunteer(s) must sign a liability waiver before they can begin work at the park and submit the waiver to the Parks Division Liaison. Minors under the age of eighteen (18) must have a parent/guardian signature.
- 3. The volunteer(s) must complete the sign-in sheet before they can begin work for each day they are at the park and submit the form to the Parks Division Liaison.
- 4. Permitted Volunteer Activities Include:
  - a. Trash and debris cleanup
    - Trash bag and debris removal must be scheduled with the Parks Division Liaison\*
  - b. Cleaning of pavilion walls, floors and tables
- 5. Special Approval Required: (Park site visit with Parks Division Liaison required)\*
  - a. Drainage channel clean-ups
  - b. Installation of any landscape material
  - c. Modifications of any type
- 6. Restricted Volunteer Activities
  - a. Removal of existing plants, rocks, or trees
  - b. Tree trimming
  - c. Painting of any kind
  - d. Mowing, weed eating, etc.
  - e. Interfering with wildlife

- 7. General Requirements:
  - a. Volunteer(s) must park in designated parking spaces and not block others utilizing the park.
  - b. Staging areas and refreshment tables for volunteers can be setup in designated areas. All trash must be disposed of properly.
  - c. Sunscreen and bug/tick spray are recommended
  - d. Note: parks are natural areas and you may encounter any manner of venomous wildlife and/or poisonous vegetation. Protective clothing and closed toed shoes should be worn at all times.
- 8. The City of Hurst reserves the right to modify the guidelines at any time.
