### Hurst Aquatics Center Rules

**Thanks for visiting us! Please keep the following rules and policies in mind to help ensure a safe and FUN visit!**

- Read and comply with all posted signs.
- Follow all instructions given by the Aquatics Center Staff.
- Children 12 and under must be accompanied by an adult ages 16 years or older.
- Children ages 5 and under or non-swimmers must be within arm's reach of an adult ages 16 years or older at all times.
- Glass containers and sharp knives are not permitted. Coolers will be inspected.
- Food and drinks are not allowed in the water.
- Only U.S. Coast Guard approved lifejackets are allowed. Outside floatation devices are not permitted as they will cover the water surface of the pools and prevent lifeguards from being able to see the bottom.
- Proper swim attire is required to enter the water.
- Please do not change diapers on deck or furniture.
- In the event of an emergency, please contact the nearest Lifeguard.
- Hurst Aquatics Centers are alcohol, tobacco, and smoke free facilities. E-cigs and Juuls are not permitted. Abusive or profane language is not be tolerated.
- The City of Hurst is not responsible for lost or stolen items.
- Weapons of any type are prohibited on park property.
- Guests may exit the park and re-enter throughout the day. Upon exiting, guests must have their hand stamped by the cashier for re-entry into the park.
- Only service animals required for medical reasons will be allowed in the park.
- If park operation is suspended due to inclement weather up to one hour prior to the posted closing time, guests who have been admitted to the park will receive a complimentary pass. Management reserves the right to suspend operation and/or close the park at any time and initiate the raincheck policy. No refunds or early issued rain checks are given.

### **Locker Rentals:**

- Lockers may be rented at the ticket window.
- Daily locker fee is \$1.00.
- Driver's license or season pass is needed to check out a key.
- Please return the key to the ticket window upon exiting the facility.
- In the event of a lost key, a \$5.00 replacement fee is charged.
- The City of Hurst is not responsible for any theft of, or damage to, personal belongings stored in the lockers.
- Lockers will be emptied daily.

### **Tot Pool:**

- The water depth is 0" to 12".
- Only children ages 4 & under may use the Tot Pool.
- Children 12 and under should be directly supervised by an adult ages 16 and older.
- Non-potty trained children must be in swim diapers with a swimsuit over the diaper; Please do not change diapers on the deck.
- Please do not drink the pool water.
- Only U.S. Coast Guard approved lifejackets allowed.
- No food or drinks allowed in the water.
- No running on or around the features.
- No diving or horseplay allowed.
- No headfirst sliding on the slide.

### **Activity Pool:**

- The water depth is 0" to 36".
- Only U.S. Coast Guard approved lifejackets allowed.
- City provided tubes are NOT ALLOWED in this pool.
- Non-potty trained children must be in swim diapers with a swimsuit over the diaper; Please do not change diapers on the deck or furniture.
- Children 12 and under should be directly supervised by an adult ages 16 and older.
- Please do not drink the water.
- No food or drinks allowed in the water.
- No running on or around the features.
- No diving or horseplay allowed.
- No headfirst sliding on the slides. No climbing on the pipes or handrails.
- Maximum weight on the play structure is 200 pounds.

### **River Pool:**

- Please enter and exit using the steps.
- The water depth is 42”.
- Only City provided tubes allowed in the River Pool.
- Tubes must remain within the confines of the River.
- One person per tube.
- Children ages 5 and younger must be within arm’s reach of an adult at all times.
- Non-potty trained children must be in swim diapers with a swimsuit over the diaper; Please do not change diapers on the deck or furniture.
- Please do not drink the water.
- No diving or horseplay in this area.
- Only U.S. Coast Guard approved lifejackets allowed.
- No food or drinks allowed in the water.

### **Diving Pool:**

- The water depth is 12 feet 6 inches.
- Non-swimmers are not allowed.
- Lifejackets are not allowed.
- Only one guest allowed at a time on each board.
- Only one bounce permitted.
- After entering the water, guests should swim to the nearest ladder and exit.
- Other Guests should wait for the previous user to reach the ladder to exit the pool.
- Guests are not allowed to catch children jumping off the boards, nor assist them to the ladders.
- Non-standard dives, such as cartwheels, hand-stands, back dives, gainers, sit dives, etc., are not allowed.
- Eyeglasses, goggles, masks are not permitted.
- No leisure swimming allowed in the Diving Pool.
- Do not swim into or otherwise block the Drop Slide splash down zone.
- No food or drinks allowed in the water.
- Maximum weight on the diving boards is 250 pounds.

## **Slide Tower Rules:**

For all slides please...

- Single riders only! Only one guest may enter flume at a time.
- Forming chains is not allowed.
- Guests must wait for the Attendant's start signal before starting the ride.
- Keep arms and hands inside the flume at all times.
- Do not run, dive, stand, kneel, rotate, or stop in the slide.
- Cutting in line, horseplay, and other unsafe behaviors are not permitted.
- Swim wear with exposed zippers, buckles, rivets, or metal ornamentations is not allowed.
- Lifejackets are not permitted.
- Eyeglasses should be securely strapped with head straps.
- For safety reasons, pregnant women and persons with heart conditions or back problems should not ride the slides.
- Maximum weight on the slide is 250 pounds

## **Blue/Yellow Run-out Slides:**

- Guests must be a minimum of 40" tall to ride the Run-out Slides.
- Slide must be ridden feet first lying on your back, or in a sitting position.
- At the end of the slide, obey all Lifeguard instructions and exit quickly.

## **Orange Drop Slide:**

- The pool is 12 feet 6 inches deep. You must be a strong swimmer to use this ride!
- Guests must be a minimum of 48" tall to ride the Drop Slide.
- Slide must be ridden feet first lying on your back with legs firmly crossed at the ankles and arms folded across the chest. Riding this slide improperly may cause injury.
- Do not uncross your legs or attempt to sit up.
- At the end of the slide, obey all Lifeguard instructions and exit at the nearest ladder

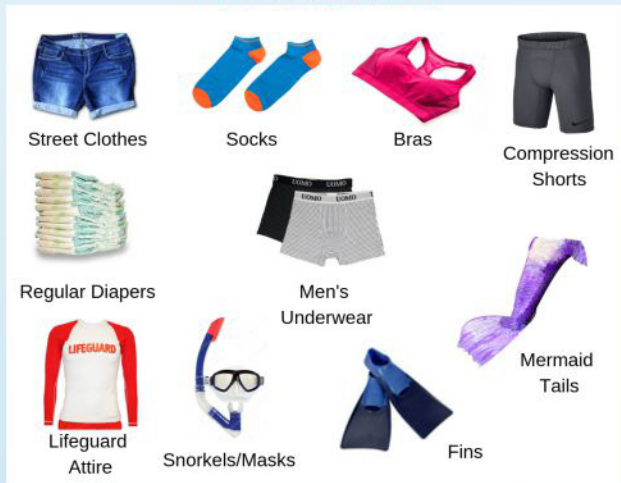

## SWIM ATTIRE REQUIREMENTS

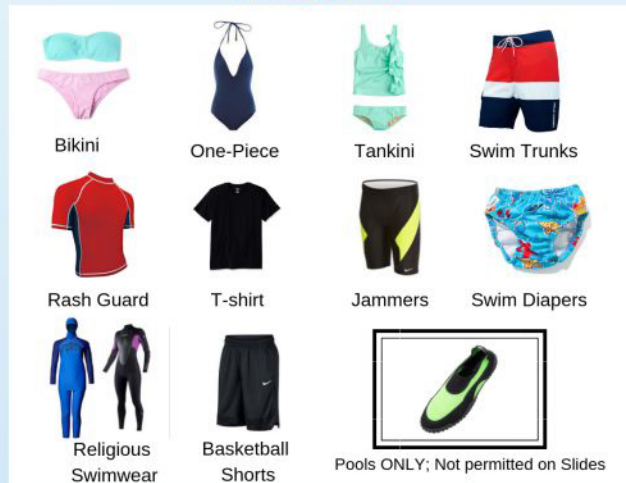
- PROPER SWIMWEAR IS REQUIRED IN ALL POOLS AND TO RIDE ALL SLIDES.  
A SWIMSUIT IS DEFINED AS AN ARTICLE OF CLOTHING DESIGNED TO BE USED IN THE POOL ENVIRONMENT.
- SWIMWEAR SHOULD BE LINED AND MAY NOT BE TRANSPARENT AT ANY TIME.
- THE FOLLOWING ATTIRE IS NOT ALLOWED IN THE POOLS AT OUR HURST AQUATICS CENTERS:
  - THONG OR T-BACK SWIMWEAR BOTTOMS, FINS, SNORKELS, GOGGLES THAT COVER THE NOSE, AND MERMAID TAILS.
  - NO UNDERGARMENTS (I.E. BRAS OF ANY KIND) MAY BE VISIBLE.
  - ATTIRE WITH A "LIFEGUARD" LOGO IS NOT PERMITTED FOR LIABILITY REASONS.
- SWIMSUITS WITH ZIPPERS AND FOOTWEAR ARE NOT ALLOWED ON OUR SLIDES.
- FOR SANITARY REASONS, ALL INFANTS/TODDLERS THAT REQUIRE A DIAPER MUST WEAR SWIM DIAPERS AND PROPER SWIMWEAR.

MANAGEMENT HAS THE RIGHT TO REMOVE GUESTS WHO ARE NOT COMPLIANT WITH OUR SWIM ATTIRE REQUIREMENTS.
