Instructions for a Defendant Requesting a Court Setting Without Posting Bond

If you have tickets for which alias warrants have been issued because of your failure to appear in court at a previous time, then you may request a court setting without the requirement of posting a bond by completing the attached form (Defendant's Request for Court Setting Without Posting Bond).

You must contact a bonding company to obtain a quote as to what their charge would be to post the bond(s) for you. You must contact an attorney to obtain a quote as to what his/her charge would be to post the bond(s) for you. You must include that information on your application. Further, you must complete the attached community service application and submit it with your request. Both forms must be completed legibly with no items left blank. If an item does not apply to you or your case, please put "NA" in that blank.

Return the completed Request and Application for Community Service to the clerk. The clerk will then submit your request to the judge who will either grant or deny your request. If your request is granted, you will be given a court date and will be approved for community service. If you wish to take care of your ticket at the clerk's window prior to the court date, you may do so and received community service in lieu of a payment plan. DO NOT MISS YOUR COURT DATE. This is a one-time opportunity. If you do not appear for your court setting, your tickets will return to warrant and an additional Failure to Appear may be issued.

If your request is denied, your tickets will remain in warrant. The clerk can explain your other options regarding tickets in warrant.
